## Proposal to Combine 6th Grade Volleyball and Basketball

### Current 6th Grade Sports for Western Boone Community Schools

- Athletes at Granville Wells and Thorntown are allowed to compete in the following Junior High sports at Western Boone: B&G Tennis, Coed Cross Country, B&G Soccer, Wrestling, B&G Swimming, Coed Track, Baseball, and Softball.
- Granville Wells and Thorntown offer the following sports for 6<sup>th</sup> graders to compete at their respective schools: Volleyball and B&G Basketball

#### Proposed Additions to Western Boone Junior High Athletics

 Add 6<sup>th</sup> grade teams for Volleyball and B&G Basketball under the direction of the Western Boone Junior High Athletic Department.

## Why We Are Proposing These Changes and What are the Benefits From these Changes

- Combining 6<sup>th</sup> grade sports will allow our athletes to come together quicker as a group.
  - 1. Currently, our 7<sup>th</sup> graders face a big transition period in these sports as it pertains to coming together quicker as a team due to the "rivalry" that exists between Granville Wells and Thorntown. This change will aid in improved chemistry/cohesion.
- Gives our athletes at the 6<sup>th</sup> grade level the best chance to compete against the best competition.
  - 1. Combining 6<sup>th</sup> grade teams will allow us to give our athletes a more competitive schedule and compete against more "like-sized" schools.
- Given our school size and classification level, this allows our athletes to be on a more level playing field with the schools we have to compete with.
  - 1. Individual skill development is a vital part of our Junior High sports programs; however 6<sup>th</sup> grade athletics is a time when the emphasis should begin to lean toward team success and competitiveness.
  - 2. Of the 5 schools currently in our Volleyball and Basketball sectionals (Crawfordsville, Frankfort, Lebanon, North Montgomery, Western Boone), we are the only school that does not have a combined 6<sup>th</sup> grade team for each of these sports.

### How the New Proposal Will Work

- Beginning in the 2014-2015 school year, 6<sup>th</sup> grade teams in the sports of Volleyball and B&G Basketball will compete as Western Boone teams and no longer as Granville Wells and Thorntown.
- The 6<sup>th</sup> grade teams will come under the guidance of the Western Boone Junior High Athletic Department.
- Contests will be scheduled by the Junior High Athletic Director.
- Contest officials will be hired by the Junior High Athletic Director.
- 6<sup>th</sup> grade coaches will be hired and under the guidance and supervision of the Junior High Athletic Director.
- All home contests will be played at Western Boone Jr.-Sr. High School.
- All practices (when applicable) will be held at Western Boone Jr.-Sr. High School.
  - 1. Granville Wells and Thorntown gyms may still be needed for 6<sup>th</sup> grade practices due to the high volume of winter sports and gym use at Western Boone Jr.-Sr. High School.
- The Elementary Principals with the help of the Junior High Athletic Director will work together with the supervision of these contests.

# Handbook Revisions for 2014-15 School Year

- 1. Page 10- Remove (i.e. smoking, chewing, dipping of any tobacco product), Add- and/ or any product containing nicotine.
- 2. Page 11- <u>Remove-</u> Harassing students, Bullying and Intimidation (1), <u>Add</u>- Harassment and /or Intimidation (Deal with on individual basis).
- 3. Page 16 Leggings, yoga pants, spandex, or any style of tight fitting sweat pants are <u>not to be</u> worn at school, without a covering that is fingertip length.
- 4. Page 19- After the definition of bullying, <u>Add-</u> In bullying situations, the following actions will be taken (levels can be skipped due to the seriousness of the offense). The types of bullying includes Verbal, Physical, Social/ Relational and/ or Electronic.

First Offense: Educate the person initiating the bullying (perpetrator) and the target (and supporters, if identified). The perpetrator will meet with his/her counselor and receive a verbal warning. The parent/guardian will also be notified.

Second Offense: A discipline referral, resulting in one hour of detention and a telephone conference with parents/guardian.

Third Offense: A discipline referral resulting in a Friday School. Again, the parent/guardian and SRO will be notified.

Fourth Offense: A discipline referral, up to five days of Out-Of-School suspension, and notification of the parent/guardian and SRO.

Fifth Offense: A discipline referral for five or more days of Out-Of-School suspension, and/or possible recommendation for expulsion. The parent/guardian and SRO will be involved.

NOTE: Depending on the severity of the behavior, a student may be arrested and charged with a crimmal offense

- 6. Page 20- Grading scale for Western Boone Jr.-Sr. High School; **Remove-** A+ 100 etc.., **Add-**

- 7. Page 20-<u>Remove</u>- ACP classes..., <u>Add</u>- Classes designated as AP, ACP, or college credit (from the Indiana Core Transfer Library) receive weighted grades (5.0 scale). All other classes will remain at 4.0.
- 8. Page 26- Remove- Students are not to bring Walkman or any other type of radio, CD player, stereo, tape player, trading cards, or items of substantial value to school or school functions.
